1. Call to order and approval of agenda

4. Follow-up to October 8, 2025, workshop - Cosgrove & Co

The Governance Review Task Force debriefed on the outcomes from the October 8 workshop and considered next steps. Cosgrove & Co. suggested that prior to proceeding with the Round 2 consultations, the Regulators/Members be asked to sign a non-binding letter of intent (LOI) which would outline that Engineers Canada's Primary Purpose as that of a National Alliance. Discussion was supported by pre-circulated slides: Governance Review and Consultation: Debrief on Round 1 Workshop and Advice on Next Steps. A discussion ensued.

The Task Force agreed that the Members required more information on the National Alliance model and how it informs a governance structure but cautioned against extending the review timelines by asking the Members to sign an LOI. It was recommended that:

- Cosgrove & Co. draft a letter to interest holders summarizing the key outcomes of the workshop, notably the support for a National Alliance model. The Task Force will address feedback to the letter, as required.
- Cosgrove & Co. request the opportunity to present to the Presidents Group in December, with the Task Force chair, Engineers Canada Board and CEO present. The Presidents would be asked to relay information about the governance review to their Councils.

5. Other business

There was no other business.

6. Next Task Force meetings (proposed)

The Task Force was satisfied with the proposed meeting schedule. It was noted that at the November 4 meeting, the Task Force will review the letter discussed under item 4, the final report on the Round 1 consultations, and the plan for Round 2 consultations.
