1.3 Conflict of interest

CEQB members have an ongoing obligation to conduct themselves in an ethical, professional, and lawful manner, and to identify and disclose actual, reasonably perceived, and potential conflicts of interest. These obligations are set out in case law and are also codified in statute, under the *Canada Not-for-profit Corporations Act* ("CNCA"). Members that cannot act in the best interests of Engineers Canada or are conflicted should recuse themselves from the relevant part of the meeting, and they shall not vote on the decision at hand. Members must support the legitimacy and authority of CEQB decisions, regardless of their personal position on the issue, and shall not publicly discuss the varying opinions of individual members.

4. Committee and Task Force reports (attachments 4.1 & 4.2)

4.1 Task Force on Workplace Gender Equity

Margaret Anne Hodges, Task force Chair, presented:

- Engineers Canada staff are working on new communications strategies for the release of the
 Guideline for engineers and engineering firms on workplace equity for women, in addition to its
 usual communications initiatives (i.e., publishing the guideline on the Engineers Canada website,
 sharing it on Engineers Canada's social media platforms and the Engineering
 Matters newsletter).
- The committee restructured the document and move some content from the body of the guideline into the appendices to make it more approachable.
- Suggestions from the regulators, OSPE and 30 by 30 champions were taken into consideration to make this a useable guide.
- A CEQB member commented that it would be interesting to do an environmental scan to find out how the document is being used and that the document could be easily adapted to other areas of equity.
- A CEQB member shared additional important resources to add: Engineers Canada EDI online Training webinar, Engineers and Geoscientists BC EDI Guideline (Action item 120.1)
- A CEQB member recommended that communications plan for the Guideline on workplace equity for women include development of a one-pager (Action item 120.2)
- The Guideline on workplace equity for women to be sent to the Engineers Canada Board for approval at the September 29th Board meeting. (Action item 120.3)
- Following the final approval of this guideline by the Engineers Canada Board, the Task force on Workplace Gender Equity will be stood down. Task Force members will still be invited to participate in the development of the new communications strategies for this guideline (optional). (Action item 120.4)

Motion: **THAT** the final public Guideline on workplace equity for women be recommended to the Engineers Canada Board for approval and that the Task Force on Workplace Gender Equity be stood down, with gratitude from the CEQB was moved by Karen Savage and seconded by Marisa Sterling. None were opposed. Marcie Cochrane abstained, stating a conflict of interest. The motion carried.

4.2 Task Force on Alternative Methods of Academic Assessment

Amy Hsiao, Task force Chair, presented:

- Keith Johnson Consulting worked with the task force to develop the study in June-July 2022, basing content on the CEQB approved general direction.
- Study is based around SWOT analyses of methods that are currently in use, as well as
 options that could be implemented should the regulators choose



- Note that these are not intended as recommendations; Rather, they are meant to provide a springboard for discussion
- Proposing a unique consultation approach, given the purpose of the paper to generate discussion
 - Gather the regulators and other key stakeholders for a summit to discuss the paper's findings and identify areas of consensus and disagreement
 - Findings from the summit will be appended to the final study that goes for CEQB and Board approval (Action item 120.5)
- A CEQB member felt that the weaknesses provided on the SWOT Analysis-CEQB Syllabi could be reframed as strengths and hopes to see valuable feedback from the regulators and key stakeholders during the summit.
- There was discussion around the environment involved in CEAB teachings, this opened discussion that the point of this document is for non-CEAB applicants, and these must be in alignment but will never be the same as CEAB focuses on a program and non-CEAB applicants focuses on an individual. They are equivalent but not equal.

Motion: **THAT** the draft Feasibility study on alternative methods of academic assessment for non-CEAB applicants be approved for regulator consultation was moved by Amy Hsiao and seconded by Frank Collins. None were opposed. The motion carried.

4.3 Syllabus Committee

Kamran Behdinan, Committee Chair, presented:

- Electrical Engineering Syllabus has been sent for regulator consultation
- Currently reviewing complimentary Mechatronics syllabi which is nearing completion with plans to be approved by Syllabus committee in November.
- Chemical engineering syllabi has started with minor delays which will hopefully be resolved soon
- 2023 planned reviews: Industrial, Building and Petroleum
- Syllabus Committee has reviewed web page text and approved changes to the introductory language
- Syllabus Committee conducted a pulse check survey with regulators, and found that the syllabilities are generally well received
 - 6 people from 5 regulators responded
 - Some concerns about the timeliness of reviews (i.e. older syllabi); Syllabus Committee may recommend accelerated review cycles depending on topic
 - Structure of syllabi (e.g. Group A/B) is useful, though some expressed a desire for better equivalence with CEAB courses (i.e. some Bodies of Knowledge may be covered across multiple courses)

4.4 Executive Committee

Margaret Anne Hodges, CEQB Chair, presented:

- Met in late August to review September agenda and discuss status of CEQB's 2022 Work plan
 - Projects are largely on track though some remaining delays based on hiring delays in early 2022
 - CEQB will be in the limelight in the coming months: how can we best ensure good reception of CEQB work?



- 1:1 conversations update
 - Excellent insight into what motivates CEQB members, where they see our SWOTs
 - Conversations will continue in October

5. Other Qualifications Board business Report on CEQB Secretariat roles

Ryan Melsom, Manager, Qualifications and CEQB Secretary, presented:

Manager, Qualifications: Ryan Melsom

- Provides strategic advising to CEQB and its committees
- Plans and directs operations of Qualifications team
- Facilitates relationships with EC Board, CEOG, officials groups, CEAB, external groups
- Designs and oversees volunteer, vendor, and consulting programs

Specialist, Qualifications: Isabelle Flamand

- Manages and supports committees and working groups of the CEQB, as assigned
- Provides research and recommendations, such as environmental scans and surveys
- Leads volunteer support program for CEQB and its committee members, including onboarding
- Executes procurement and vendor management processes

Coordinator, Qualifications: Alison Peverley

- Coordinates committee meetings, national workshops, and biannual CEQB meetings
- Supports development of meeting documents, correspondence, administrative resources
- Develops positive relationships with volunteers and stakeholders; responds to volunteer inquiries
- Supports consultation and vendor processes

Policy Work: Working Groups

- 30 by 30
 - 2022 Consultation on working group report (19 recommendations)
 - Consultation closed August 31
 - Analysis of feedback underway
- Organizational Quality Management
 - Developing Documentation and Resources for Training
 - Role Descriptions for Visiting team, Decision processes, and Leadership
 - Reviewing operations to improve transparency and consistency
 - Leadership, communication and dissemination
- Implementation of Tandem
 - web-based accreditation data management system
 - targeted for 2024/2025 visit cycle

Accountability in Accreditation Evaluation:

- Assess the effectiveness, trustworthiness, transparency, and efficiency of the accreditation system
- 2022 recommendation themes (high level):
 - Investigate consistency in visits and decisions; schedule optimization
 - Improve consultation close-out and follow-up procedures
 - Develop key messaging to clarify intents and purposes of specific accreditation policies and procedures
- 2023 data collection underway
