These obligations are set out in case law and are also codified in statute, under the *Canada Not-for-profit Corporations Act* ("CNCA"). Members that cannot act in the best interests of Engineers Canada or are conflicted should recuse themselves from the relevant part of the meeting, and they shall not vote on the decision at hand. Members must support the legitimacy and authority of CEQB decisions, regardless of their personal position on the issue, and shall not publicly discuss the varying opinions of individual members.

4. Other CEQB Business

4.1 2026 work plan priorities for consultation

Frank Collins, CEQB Chair, presented

Three potential work plan items were proposed by CEQB members and officials for 2026 (proposals attached as appendices 4.1c-4.1e). Based on recent years, 2026 resources would likely allow for one new guideline, although up to two may be sent to determine regulator interest:

- Proposed New Guideline on fundamentals of consultation and engagement
- Proposed New Guideline on empathy as an engineering skill and tool
- Proposed New Guideline on the public conduct of engineers [from officials]

Amy Hsiao, Marcie Cochrane and Ryan Melsom, presented on the three proposed items. Thorough discussion from CEQB members noted that empathy as an engineering skill was what tied the 3 proposals together. It was also recommended that if not selected empathy as an engineering skill and tool would make a good workplan item for the Foresight committee.

CEQB members participated in an anonymous vote and Proposed New Guideline on the public conduct of engineers and Proposed New Guideline on fundamentals of consultation and engagement were selected as to be sent to regulators as potential new work items for 2026.

5.1 Syllabus Committee

Kamran Behdinan, Committee Chair, presented,

• Regulator interest in reviewing the revised Regulators Guideline on the academic assessment necessitated a delayed timeline



- Now planned for approval in July
- Reviews in 2025:
 - 2017 Computer engineering syllabus (2024)
 - 2018 Environmental engineering syllabus
 - 2018 Geological engineering syllabus
 - 2018 Geomatics engineering syllabus

5.2 Practice Committee

Sam Inchasi, Committee Chair, presented:

- Regulator interest in reviewing the revised Guideline on the practice of engineering necessitated a delayed timeline
 - Now planned for approval in July
- New members have joined committee: John Diiwu and Adam Wallace
 - May reach out to regulators for an additional member
- In the early stages of reviewing the Guideline on qualified persons in demand-side legislation
 - Project may unfold into new regulator guidance on vexatious complaints and misuse of complaints process by the public

5.3 Foresight Committee

Sam Inchasi, Committee Chair, presented:

- Two working groups have been formed to cover development of two thought papers:
 - 1. Evolution of Engineering Education
 - 2. Technological Advances and Their Impacts
- Challenges in establishing process for this subcommittee, as it does not function according to the standard CEQB development process
 - 1. Staff workload has contributed to ability to drive the work
- Papers anticipated for completion at the July 2025 meeting
 - 1. They are planned to be presented "For information", rather than as a typical CEQB approval

5.4 Executive Committee

Frank Collins, CEQB Chair, presented:

- Met virtually on March 7 to review January meeting feedback, April CEQB meeting agenda, and work plan progress.
- Decided to develop a more formal response to the Future of Engineering Accreditation project (for discussion under item 9)
 - Prioritized this over the letter outlining the CEQB's value, as the timely delivery of feedback was important to being considered as part of the Board's decision making; this also allowed for a more collaborative approach (tomorrow's workshop)
- Sam Inchasi takes over as CEQB Chair in July

5.5 50-30 Working Group

Marcie Cochrane, Working Group Chair, presented:

- Diversity of thought is a hallmark of successful boards, and without a systematic, strategic way to encourage this, decision making can become biased and unreflective of the protection of the public that work is intended to serve.
- In April 2024, the CEQB determined that it would strike a 50-30 champions group to propose



- practices and recommendations that would facilitate thought diversity and help ensure alignment with Engineers Canada's 50-30 objectives.
- In January 2025, based on a recommendation from the 50-30 Champions and several additional CEQB members, the CEQB voted to create a 50-30 working group, whose purpose was to bring forward recommendations for improvements to CEQB practices. The working group sent a survey to CEQB members in order to inform the recommendations presented.
- The 50-30 survey feedback indicated that it was important to be clear about the goals, objectives, and impact to existing QB practices when making any 50-30 initiated policy or process change. It is important to note that as CEQB considers proposals, it must also consider unintended consequences of decisions (e.g. impacts on the openness of discussions), as well as guardrails that can be put in place to mitigate these (e.g. annual process reviews, satisfaction surveys)

- Engineers Canada reduced operating costs by \$765K between 2024 and 2025
- Will request a raise in the Per Capita Assessment Fee to \$11 in May 2025
- Decisions from February:
 - Presentation by the CEO (including information on Realizing FEA)
 - Presentations by CEO Group, Presidents, CEQB, and CEAB (workplan approved)
 - Directors accepted the Strategic Performance Report for 2024, to be presented at the AMM
 - 2025 CEO Objectives were discussed and approved

Recent NAOG Work/Discussions

- Sharing of new challenges and happenings at each regulator (roundtable updates)
- Recent NAOG initiative was launched to compile the updated practices for each regulator's approach to non-CEAB academic assessments
 - This exercise resulted from a request from the CEO Group and the eventual goal of this
 work is to further collaborate and harmonize on the policies and practices for non-CEAB
 academic assessments (where possible)
- Recent initiative to compile updated regulator practices & average processing timeframe for Canadian interjurisdictional mobility applications
 - Conducted in response to the recent federal/provincial government(s) announcements related to reducing barriers for internal labour mobility in Canada

Future NAOG Work/Discussions

- NAOG will next meet virtually on May 7th. Discussions expected to include;
 - Challenges and new happenings at each regulator
 - Overview of updated regulator practices and next steps for harmonized policy for non-CEAB academic assessments
 - Discussion on recent federal & provincial government(s) announcements on potential changes to Canadian labour mobility requirements
 - Next steps/updates related to Engineers Canada's Strategic Priority for "Realizing accreditation and academic assessments (RAAA)" (follow up to Futures of Engineering Accreditation (FEA) work)

7.2 National Practice Officials Group (NPOG) Update

Kelly Dayman, NPOG Chair, presented:

Recent NPOG Work/Discussions

- Since the last QB update, recent NPOG discussions have included;
 - Challenges and new happenings at each regulator (roundtable updates)
 - Updates related to NPOG's Classes of Licensure, CPD, and Business Entity Regulation



- tables that summarize regulator policies and practices in these areas
- Discussion on recent NPOG initiative related to "MOU on Interjurisdictional CPD Acceptance" and overview of outstanding regulator concerns with adoption
- Status of EC submission/next steps related to PSPC's "Policy Notification 48R2" which imposes requirements for bilingual engineering documents on bids for federal projects

Future NPOG Work/Discussions

- NPOG will next meet virtually on May 13th. Discussions are expected to include;
 - Challenges and new happenings at the regulators (roundtable updates)
 - Discussions on how to address increasing tension resulting from perceived scope of practice overlap between engineers and architects in many provinces

7.3National Discipline and Enforcement Officials Group (NDEOG) Update Danielle Unett, NDEOG Chair, presented:

Recent NDEOG Work/Discussions

- NDEOG last met virtually on March 6th, their discussions included;
 - Challenges and new happenings at each regulator (roundtable updates)
 - Group enforcement efforts for problematic companies inaccurately advertising services or providing services without the appropriate permit/license
 - Vexatious complaints and disruption of investigation processes

Key recent development that is of concern for engineering regulators & NDEOG

- Implications related to recent Nova Scotia government announcement on <u>Bill-36</u> ("An Act Respecting Free Trade and Mobility within Canada")
 - Bill-36, if enacted, would allow for all licensed professionals (including professional engineers) from any province/territory in Canada to be treated as though they have the equivalent license with Nova Scotia regulator (in our case, Engineers Nova Scotia)
 - Raises questions and concerns for how/which regulator(s) would have jurisdiction to discipline these individuals in event of incompetent/unsafe practice in Nova Scotia

Future NDEOG Work/Discussions

- NDEOG will next meet in person on June 4-5th in Charlottetown, PEI. Discussions are expected to include:
 - Review of NDEOG "MOU on Discipline and Enforcement"
 - Discussions on how to address issue of EITs who never progress to full licensure yet are suspected to be practicing engineering
 - Discussions on regulator protocols and practices for publication of discipline decisions and how to improve inter-jurisdictional sharing of decisions
 - Continued discussions on implications related to Nova Scotia Bill-36 & any other labour mobility developments

"To identify to the member engineering regulators of Engineers Canada those engineering programs whose graduates are academically qualified to begin the process to be licensed as professional engineers in Canada."



CEAB Accreditation Criteria and Procedures

Linkage(s) with CEQB

- Direct report of the Engineers Canada Board
- Outputs support regulators' licensing processes
- Program data collected in accreditation process supports development of CEQB syllabi
 - Otherwise publicly available information but collated in a usable format for CEQB work
 - Syllabi are not used on an accreditation visit
- Impacted by outcomes of the Futures of Engineering Accreditation report recommendations

Visits

- 2024/2025 cycle: 97 programs at 21 institutions
 - First implementation of Tandem for accreditation
- 2025/2026 cycle: 70 programs at 16 institutions
- 2026/2027 cycle: 42 programs at 15 institutions

2025 Workplan

- Operational policies and procedures
 - Visits to programs with satellite campuses and/or feeder schools; Terminating programs;
 Focused visits; Risk-based trajectory decision matrix
- Revised Interpretive statement on curriculum content for options and dual discipline programs
 - Consultation report in progress
- Study trends in Graduate Attribute and Continual Improvement (GA/CI) criteria compliance
- Reconcile the Questionnaire, GA/CI rubrics, and accreditation criteria
- Consider adding a new clause to "Appendix 1 Regulations for granting transfer credits" of the CEAB Accreditation Criteria and Procedures book
- Contributions to Futures of Engineering Accreditation recommendations
 - Exploring alternatives to the 'specified AU' criteria (course content which must be taught
