1.2 Approval of the agenda

1.3 Conflict of interest

CEQB members have an ongoing obligation to conduct themselves in an ethical, professional, and lawful manner, and to identify and disclose actual, reasonably perceived, and potential conflicts of interest. These obligations are set out in case law and are also codified in statute, under the *Canada Not-for-profit Corporations Act* ("CNCA"). Members that cannot act in the best interests of Engineers Canada or are conflicted should recuse themselves from the relevant part of the meeting, and they shall not vote on the decision at hand. Members must support the legitimacy and authority of CEQB decisions, regardless of their personal position on the issue, and shall not publicly discuss the varying opinions of individual members.

A CEQB member requested that item 2.4 *Guideline on good character* be removed from the consent agenda and added for discussion.

- Review of 2017 Petroleum engineering syllabus

5. Committee and task force approvals

5.1 Practice Committee (attachments 5.1 a-b)

Sam Inchasi, chair of the Practice Committee, presented. In early 2021, the services of an Indigenous-led consulting team from Urban Systems were engaged, and the CEQB Practice Committee began advising on the development of a series of five regional and national gatherings. These gatherings, which saw up to 50% participation from Indigenous people and which also invited engineers who have worked extensively with Indigenous communities, provided the foundation for the general direction document which received final approval from the CEQB in April 2022. The general direction, which reflects a consensus from regulators and stakeholders on the guideline's purpose and content, forms the basis on which this draft guideline has been created.

A CEQB member suggested providing more information about reconciliation in the guideline. A CEQB member questioned whether the phrases "serving the community" or "for the community" should be



shifted to "with the community" throughout the document. The Practice Committee hopes the concerns regarding further information on reconciliation can be addressed in the cover letter that will be included with the final guideline. This feedback will be incorporated as part of the consultation feedback, and addressed then. (action item 119.3)

Motion: That the draft public Guideline for engineers and engineering firms on Indigenous consultation and engagement be approved for regulator consultation was moved by Marisa Sterling and seconded by Frank Collins. None were opposed. The motion carried.

5.2 Good Character Guideline

Qing Zhao, chair of the Admissions Issues Committee, provided an overview of the updates to the guideline. The Guideline on good character was requested to be updated by the regulators given the increased dependency in 2020-2021 on virtual and remote engineering work, study, applications, and examinations. Regulators wanted the guideline to better address the ever-changing virtual world given some increased findings of things such as self-validation in the newly implemented CBA system, tampering of official documents submitted virtually, and other 'new' good character related risks. The CEQB workshop held in January was focused on these issues, and revisions were identified and deemed minimal based on discussions, regulators' feedback, and presentations.

A member asked that some minor editorial changes be made to the guideline. Changes will be made where possible before sending the document for regulator consultation. (action item 119.5)

Motion: That the draft public Guideline on good character be approved for regulator consultation was moved by Qing Zhao and seconded by Anil Gupta. None were opposed. The motion carried.
