1.2 Approval of the agenda

1.3 Conflict of interest

CEQB members have an ongoing obligation to conduct themselves in an ethical, professional, and lawful manner, and to identify and disclose actual, reasonably perceived, and potential conflicts of interest. These obligations are set out in case law and are also codified in statute, under the *Canada Not-for-profit Corporations Act* ("CNCA"). Members that cannot act in the best interests of Engineers Canada or are conflicted should recuse themselves from the relevant part of the meeting, and they shall not vote on the decision at hand. Members must support the legitimacy and authority of CEQB decisions, regardless of their personal position on the issue, and shall not publicly discuss the varying opinions of individual members.

4. Other CEQB Business

Frank Collins, CEQB Chair, presented

4.1 CEQB Foresight Committee

Frank Collins, CEQB Chair, presented

The Foresight Committee is a standing committee of the CEQB, whose purpose is to identify key issues affecting engineering regulation in the 5-to-10-year timeframe, in order to support more effective development of the CEQB's work.

The process to join the committee is through open application, and selections are made by the CEQB Executive Committee. All terms, except for that of the chair, are for a duration of 1 year, and reappointments of previous members are only possible after one year off of the committee.

A CEQB member would like to add a note to the composition of the committee to include at least one industry member to the committee.



A CEQB member questioned where workplan items would come from in future if they would be filtered through this committee and was assured work plan items would remain the same. They also had concerns about whether we were striking the environmental and sustainability committee and would like to see it left dormant but not eliminated.

A CEQB Executive member noted that the intention of this committee is to allow membership to cycle through many members by changing the membership with the single year terms.

Motion: **THAT** the Foresight Committee be struck, to operate as per the terms of reference distributed with the meeting documents was moved by Margaret Ann Hodges and seconded by Tim Kirkby. None were opposed. The motion carried.

4.2 2025 Vice Chair nominations

Ryan Melsom, CEQB Secretary, presented on behalf of Marisa Sterling, Nominating Committee Chair

- As per Engineers Canada policy 6.10, CEQB members elect their vice-chairs and pass the recommendation to the Engineers Canada Board for confirmation.
- The upcoming vice-chair role will run from July 1, 2025 to June 30, 2027.
- While this appointment is for two-years, the successful candidate is expected to continue into the chair, and past chair positions (pending Engineers Canada Board approval), for a total of six years.
- Nominations due to Ryan by June 15, 2024.

4.3 2024 priorities discussion

Frank Collins, CEQB Chair, presented

No items were submitted by CEQB members for consideration as 2025 work items

Several options:

- Can allocate resources to writing the paper on Emerging Technologies
- Officials groups will be asked during consultation for their input on potential work items that could be pursued in 2025
- Board has indicated interest in guidance for organizations overseeing engineering work
 - Looking for guidance and tools on what boards could do to ensure proper oversight of engineering work
 - Aims would be to raise awareness of engineers' work in organizations and thereby better protect the public



- February 1, 2024-Template available
- March 1, 2024-Proposed items due to Secretariat
- April 6, 2023-Potential 2025 work items reviewed at CEQB meeting
- July 2024-Work plan consultation reviewed at teleconference
- Work plan approved by CEQB
- October 2023-Work plan presented at Engineers Canada Board meeting for comments
- December 2023-Work plan approved by Engineers Canada Board

5. Committee reports

5.1 Admission Issues Committee

Qing Zhao, Committee Chair, presented

Status update:

- Consultation for a paper on the regulation of emerging disciplines closed with feedback items from 3 regulators; Committee met to discuss and review the feedback on March 19
- The final general direction document was approved by CEQB today. A draft of the paper is planned for committee review by mid to late May
- Paper is planned as a regulator-only document

Key issues:

- Paper will provide high level guidance on regulation of emerging disciplines, but future direction may still be needed on processes for regulators to use the model
- Some overlap with themes from the review of the guideline on EIT supervision, so this will be considered in the final version of the paper

A CEQB member requested that they add a component to the paper on engaging with industry.

A CEQB member pointed out a few grammatical corrections to review.

Motion: **THAT the final General direction for an Engineers Canada paper on the regulation of emerging disciplines be approved. Was moved by Qing Zhao and seconded by Kamran Behdinan. None were opposed. The motion carried.**

Action items: 126.1, 126.2

5.2 Continuing Competence Committee

Anil Gupta, Committee Chair, presented

Status update:

- Committee met to approve the draft guideline
- Outstanding committee feedback to be addressed as part of the consultation
- The guideline is very timely, as several regulators are now undertaking substantial reviews of their policies around fitness-to-practice

Key issue:



• The draft guideline provides direction on a public-facing component; the development of this after the document's publication will take substantial time in 2025

A CEQB member felt that a review of the legacy of work done by the registrant that could have been affected by the fitness to practice issue should be carried out and is important to add to the cover of the guideline. They also sent edits to the secretariat to be included in the consultation feedback.

Motion: THAT the draft Regulators Guideline on fitness to practice be approved for regulator consultation. Was moved by Anil Gupta and seconded by Karen Savage. None were opposed. The motion carried.

Action item: 126.3

5.3 EIT Committee

Amy Hsiao, Committee Chair, presented

Status update:

- The committee received 55 pieces of feedback from 6 regulators—one of the most substantial consultations in recent memory
- All feedback was addressed and the guideline was presented for approval today
- Will go for Board approval in October

Key issue:

• The guideline discusses how to enhance competencies, but the Pan-Canadian competency framework has been updated since the last time the guideline was revised; however, the committee decided not to focus exclusively on this, due to jurisdictional differences

A CEQB member noted that consistency with wording throughout the guideline when referring to professional engineers was important. It was noted that using one term throughout and including terms in the glossary would be the right approach.

Motion: THAT the final revised Guideline on assuming responsibility for the work of engineers-intraining be approved. Was moved by Amy Hsiao and seconded by Ian Sloman. None were opposed. The motion carried.

Action item: 126.4

5.4 Syllabus Committee

Kamran Behdinan, Committee Chair, presented

Status update:

- Syllabi continue to be one of the most widely used CEQB products, presenting significant value for regulators
 - CEQB regularly receives detailed feedback on syllabi, indicating a high level of engagement and value
- Reviews in 2024:



- 2007 Building engineering (final approval April 2024)
- o 2017 Petroleum engineering (final approval July 2024)
- 2016 Naval Architectural engineering syllabus
- 2017 Computer engineering syllabus
- 2018 Mining and Mineral processing engineering syllabus
- o 2018 Environmental engineering syllabus (tentative)

There was some discussion brought up by a CEQB member whether certain industry practices should be included in the syllabus. It was noted that the general practice with syllabi is to follow CEAB programs.

Motion: THAT the final revised Building engineering syllabus be approved and published on the public website. Was moved by Kamran Behdinan and seconded by Karen Savage. None were opposed. The motion carried.

Action item: 126.5

5.5 Practice Committee

Sam Inchasi, Practice Committee Chair, presented

Status Update:

- Three guidelines were approved by the CEQB in January 2024 to be presented to the Engineers Canada Board for final approval in May: Duty to report, Conflict of interest, Code of ethics
- Two guidelines are being revised in 2024:
 - Guideline on good character (to include principles of character investigations) for regulator consultation April-June 2024.
 - o Guideline on the practice of engineering in Canada

Key issues

- Regulators are interested in the guideline on Practice of engineering in Canada, as it has been used in several recent court cases;
 - Because it has no legal authority, there is a question of the value of having a national guideline

A CEQB member had some feedback to improve the Guideline. Their suggestions have been noted for consultation feedback.

Motion: THAT the draft revised Guideline on good character (with principles of character investigations) be approved for regulator consultation. Was moved by Sam Inchasi and seconded by Karen Savage. None were opposed. The motion carried.

5.6 Executive Committee

Frank Collins, CEQB Chair, presented

Status update:

- Met virtually on March 8 to review January meeting feedback, April CEQB meeting agenda, and work plan progress.
- Discussed potential options for streamlining CEQB administration



- Staff will be exploring ways to reduce administrative load in subcommittee meetings
- o Recommendations to be made on reducing subcommittee size
- Translation resources to be focused more on documents going for consultation, to better align with expectations of other Engineers Canada Board committees
- Suggestions from CEQB members welcome

5.7 Nominating Committee

Marisa Sterling, Nominating Committee Chair, presented

Status update:

• As per Board Policy 6.10, all discussion about nominees is considered confidential, so only high-level information

can be shared:

- 1 Regulator has submitted regional member nominees for Engineers Canada Board approval (Engineers and Geoscientists BC)
- 2 Reappointments have been considered and submitted for Engineers Canada Board approval
- 1 member-at-large has been recommended to the Board for approval
- Announcements will be made following the May Board meeting
- This year, we expanded our outreach efforts to promote the member-at-large position:
 - Shared in the 30 by 30 newsletter
 - o Shared on Engineers Canada's social media channels, newsletter, and website
 - Revised posting language to highlight our commitment to fostering a diverse and representative membership
 - Held a Q&A webinar to share more information about the CEQB's work and current members' experience
- Next year, we will be implementing a more fulsome communications plan for the recruitment of new CEQB members.

Al Stewart, CEAB Member, presented:

Why engineering education accreditation matters

- Graduates exempted from writing confirmatory technical exams for licensure.
- International agreements provide mobility for graduates.
- The profession expresses expectations for graduates through criteria.
- Flexibility helps institutions develop innovative programs in new fields.

Linkage(s) with CEQB

- Direct report of the Engineers Canada Board
- Outputs support regulators' licensing processes
- Program data collected in accreditation process supports development of CEQB syllabi
 - Otherwise publicly available information but collated in a usable format for CEQB work
 - o Syllabi are not used on an accreditation visit
- Impacted by outcomes of the Futures of Engineering Accreditation project



Visits

- 2023/2024 cycle: 30 programs at 13 institutions
 - Decisions at June 2024 meeting
- 2024/2025 cycle: 95 programs at 21 institutions
 - o First implementation of Tandem for accreditation
- 2025/2026 cycle: 98 programs at 25 institutions
 - Offered extensions of accreditation to 25 programs at 8 institutions to re-balance the 25/26 and 26/27 visit cycle

Tandem

Implemented for the 2024/2025 visit cycle

- Configured off-the-shelf solution with some customization.
- Use by programs to submit Questionnaire and by visiting teams to complete their reviews and write their observations. Replace Word- and Excel-based tools and forms.
- Significant training and change management underway
- Feedback to-date:
 - o Users are feeling well-supported with multiple opportunities to be trained on the system
 - o User interface, reduced data duplication, and stable records management all positives
 - Room for improvement to further reduce manual data entry, granular levels of permissions, audit log of changes

Proposed action/recommendation

- 1. Staff will submit changes to the CEQB <u>Handbook</u> section 6.10.1.C(10) on pages 70-71 to reflect the commitment to the 50-30 Challenge
- 2. CEQB will assign at least two members to be champions of this motion and who will lead the gap and opportunities analysis, guided by the Government of Canada's 50-30 Challenge What Works Toolkit.
- Interested CEQB members will work with the champions and staff to facilitate a self-reflection discussion with the CEQB in the summer of 2024 on procedures <u>factors</u> such as member skills, diversity, recruitment, and onboarding along with CEQB subcommittee composition and inclusive culture.
- 4. The champions will consider Engineers Canada's more robust skills matrix in its Board policy manual for possible adoption by the CEQB to improve its recruitment efforts
- 5. The champions will bring a set of recommendations to the CEQB at their September 2024 meeting based on the outcomes of the self-reflection, including policy recommendations for consideration by the Engineers Canada Board.
