1.2. Approval of the agenda

1.3. Conflict of interest

CEQB members have an ongoing obligation to conduct themselves in an ethical, professional, and lawful manner, and to identify and disclose actual, reasonably perceived, and potential conflicts of interest. These obligations are set out in case law and are also codified in statute, under the *Canada Not-for-profit Corporations Act* ("CNCA"). Members that cannot act in the best interests of Engineers Canada or are conflicted should recuse themselves from the relevant part of the meeting, and they shall not vote on the decision at hand. Members must support the legitimacy and authority of CEQB decisions, regardless of their personal position on the issue, and shall not publicly discuss the varying opinions of individual members.

4. Committee Reports

EIT and Continuing Competence Committee

Frank Collins, CEQB Chair, presented:

Status update:

• The final revised Guideline on assuming responsibility for the work of engineers-in-training, the revised guideline on good character, and the new Regulators Guideline on fitness to practice will all be presented to the Engineers Canada Board for final approval on October 10.



- Following Board approval, the guidelines will be published on the Engineers Canada website.
- As neither the EIT Committee nor the Continuing Competence Committee has any remaining work, they will become dormant.

4.1. Admission Issues Committee

Marcie Cochrane, committee chair, presented,

Status update:

- Met mid-August to review and approve the draft Engineers Canada paper on the regulation of emerging disciplines
 - Offers an original model for assessing and evaluating the emergence of new areas of practice
- Following today's approval, will be sent for consultation and then finalized for approval at the January CEQB meeting (Board approval next May) **Action item 128.3**

Key topics:

- Are there supplementary resources that could be developed to improve regulator engagement when the paper is complete?
- Board has regularly had questions about how to approach emerging disciplines, and this
 provides a valuable, actionable resource to assist in this area.

4.2. Syllabus Committee

Kamran Behdinan, committee chair, presented,

Status update:

- Syllabi continue to be one of the most widely used CEQB products, presenting significant value for regulators
 - CEQB regularly receives detailed feedback on syllabi, indicating a high level of engagement and value
- All 2024 syllabi reviews are underway now:
 - Naval architectural engineering (currently in consultation until September 30, 2024)
 - Mining and mineral processing engineering (currently in consultation until September 30, 2024)
 - Computer engineering (under revision)
 - Petroleum engineering (approval today)
 - In 2025, the committee will most likely review geomatics, geological, and environmental syllabi

Key topics:

- Public Guideline on the academic assessment of non-CEAB is under review, and is likely to be a high-profile piece of work for CEQB
 - Regulators are interested in its implications for the next phase of the Futures of Engineering Accreditation (FEA) work
 - The legal landscape has changed significantly since the last iteration, with new fairness legislation being introduced in multiple jurisdictions
- There are also questions about how syllabi will be developed reviewed if accreditation shifts from assessing inputs and outcomes to an outcomes-only model
 - What is the Syllabus Committee's role if the Engineers Canada Board and regulators



choose to implement the National Academic Requirement for Licensure?

4.3. Practice Committee

Sam Inchasi, committee Chair, presented:

Status Update:

- The new Guideline on the duty to report was approved by the Engineers Canada Board earlier this year, and is now available on the Engineers Canada website.
- The revised Guideline on code of ethics and the revised Guideline on conflict of interest were also approved by the Board earlier this year, and have been published on the Engineers Canada website.
- The revised Guideline on good character, which now includes principles for character investigations, will be presented to the Board for final approval in October.
- Review of the 2012 Guideline on the practice of engineering in Canada
 - o The committee met in late July to discuss initial revisions.
 - The committee decided to temporarily pause the initial revisions as there was a need for further insight from regulators at this stage.
 - o A short survey will be distributed to regulators this month.
 - Their feedback will be crucial in guiding the review, particularly in:
 - o assessing whether the current definition is appropriate
 - o determining if the guideline should be public-facing or for regulators only
 - The draft revised guideline will be presented in January for consultation approval.

4.4. Foresight Committee

Sam Inchasi, committee Chair, presented:

- Regulator and CEQB members are now selected:
 - Sam Inchasi (Chair ex officio appointment)
 - Anil Gupta (CEQB)
 - Farzad Rayegani (CEQB)
 - Kalina Bacher-René (OIQ)
 - Marina Solakhyan (PEO)
- Social media strategy being rolled out to locate industry members
- Held first meeting in early September, which explored three topics
 - Reasons for interest in joining the committee
 - o Issues affecting the profession or its regulation in the 10-year timeframe
 - Potential thought paper topics
- Plan to finalize topics this fall and begin work on thought papers

4.5. Executive Committee

Frank Collins, CEQB Chair, presented:

S tatus update:

- Met virtually on August 21 to review July meeting feedback, September CEQB meeting agenda and workshop, and work plan progress.
- At October Board meeting will present three guidelines for final approval
 - New Regulators guideline on fitness to practice
 - o Revised Guideline on good character
 - Revised Guideline on assuming professional responsibility for engineers-in-training
 - 2025 CEQB work plan will be presented for information (approval December)



 Chair will attend fall Board workshop on the Futures of Engineering Accreditation path forward report

Status update:

6. Report on 50-30 champion activities

Marcie Cochrane and Tim Kirkby, CEQB 50-30 champions, presented:

The 50-30 Challenge is an initiative between the Government of Canada, Canadian businesses and diversity organizations.

The goal of the program is to challenge Canadian organizations to increase the representation and inclusion of diverse groups within their workplaces, while highlighting the benefits of giving all Canadians a seat at the table.

The 50-30 Challenge asks that organizations aspire to two goals:

- Gender parity (50% women and or non-binary people) on Canadian board and/or in senior management; and
- Significant representation (30%) on Canadian boards and/or in senior management or members
 of other equity-deserving groups, including those who identify as Radicalized, Black, and/or
 People of colour ("Visible Minorities"), People with disabilities (including invisible and episodic
 disabilities0, 2SLGBTQ+ and/or gender and sexually diverse individuals, and Aboriginal and/or
 Indigenous Peoples. The program and participants recognize Indigenous Peoples, including First
 Nations, Metis and Inuit, as founding Peoples of Canada and underrepresented in positions of
 economic influence and leadership.

Engineers Canada Board Policy Manual (31 May 2024)

Within section 6.10 CEQB, subsection C. Composition

- 11) In the selection of members for the CEQB, reasonable effort shall be made to achieve a diverse membership, representative of the Canadian population and in alignment with Engineers Canada's commitment to the federal government's 50-30 Challenge:
- a) 50 per cent women and/or non-binary people; and,
- b) 30 per cent representation of other equity-deserving groups, including those who identify as Racialized, Black, and/or People of colour, People with disabilities (including invisible and episodic disabilities), 2SLGBTQ+, and Indigenous Peoples (First Nations, Métis and Inuit).



Given the interconnected nature of identity categories such as gender, race, and ability, it is understood that these categories may be overlapping. Regulators are encouraged to follow the latest bias-free recruitment techniques and actively recruit equity-deserving groups.

Within section 6.10 CEQB, subsection C. Composition

E. Planning

- (1) The CEQB is responsible for the preparation of a work plan and a volunteer recruitment and succession plan and will operate within those plans.
- a) The CEQB shall produce and maintain a work plan that includes a list of the ongoing work and identifies the volunteer resources needed to accomplish the work.
- b) The CEQB shall maintain a list of its members, including appointment dates and positions. This information shall be used as the basis for the preparation of a volunteer recruitment and succession plan that identifies the desired profiles for new appointments.
- (2) The plans must be submitted annually to the Engineers Canada Board for approval

7. Report from the Accreditation Board

Jeff Pieper, CEAB Chair Presented:

Ongoing work of accreditation – Highlights:

- 2024/2025 requests for accreditation
 - o 21 higher education institutions (HEIs), 97 programs (3 new)
- 2025/2026
 - o 16 HEIs, 70 programs
- 2026/2027
 - o 15 HEIs, 42 programs

Advances in 2024 workplan

- Transition to Tandem
- Approved for consultation (Fall): Revised *Interpretive statement on curriculum content for options and dual discipline programs*
- 30 by 30 Task Force consultation report and revised recommendations to be published and submitted to the Engineers Canada Board for direction

Accountability in Accreditation – 2024 recommendations

- Improve communications about the roles of interest holders in the accreditation system as well as the decision-making process
- Clarify the instructions for required visit materials
- Further investigate interest holder perceptions of the benefits of accreditation, consistency in the application of criteria, and process timelines
- Explore opportunities to make the accreditation system more efficient for all actors

8. National Groups

8.1. National Admissions Officials Group update

Kate MacLachlan, NAOG Chair, presented:



NAOG recent discussions at meetings have included;

- Challenges and new happenings at each regulator
- International Engineering Alliance (IEA) meeting updates and regulator practices related to acceptance of international mobility agreements
- Updates from Engineers Canada on SP 1.1 Future of Engineering Accreditation (FEA) and Strengthening Collaboration and Harmonization
- Title of "Member in Training (MIT)" and potential changes to title offerings across the country
- Updates to National Reference Points with updated admissions practices

NAOG will meet again next week (September 17-18th). Discussions will include;

- Challenges and new happenings at each regulator
- Engineers Canada's Strategic Priority updates and consultations
- Mutual recognition/international mobility agreements
- Discussion on potential areas for further alignment on core regulatory functions such as processing transfer applicants, academic review processes, etc.
- Changes to CBA system and experience assessment practices

8.2. National Practice Officials Group update

Kelly Dayman, NPOG Chair, presented:

Since the last QB update, recent NPOG discussions have included;

- Challenges and new happenings at each regulator (including new or update guidelines and standards)
- The development of a new MOU on "Interjurisdictional CPD Acceptance" and the terms and conditions associated with it's implementation
- Engineers Canada's Strategic Priorities Updates on SP 1.1 Futures of Engineering Accreditation and SP 1.2 Strengthening Collaboration and Harmonization
- PSPC's Official Languages Act in Federal Procurement and potential complication for engineers submitting project bids and documents in both French and English.
- Over the summer, NPOG members also provided their updated responses to the NPOG "CPD",
 "Business Entity Regulation" and "Classes of Licensure" tables that compile information on each
 regulator's current practices, offerings and requirements for their CPD programs, corporate
 registration permits and license offerings.
- NPOG's next meeting is scheduled in person for November 2024 (in Saskatoon, SK)

8.3. Comments from regulators

A staff member from EGBC shared that CEQB products are of great use to regulators and pointed
out the benefit of their collaboration with CEQB. They also requested a consideration for
consolidating requests and data shared to help with workload and regulators ability to
collaborate efficiently.

9. Futures of Engineering and Accreditation (SP 1.1) Update

Mya Warken Manager, Accreditation and CEAB Secretary, Annette Bergeron, FEA project Steering Committee Chair, Trina Hubley, Vice President, Regulatory Affairs and Coeuraj presented:

Engineers Canada's 2022-2024 strategic plan includes a priority to review and potentially update the



engineering accreditation process, led by the CEO. This involves benchmarking the current system, exploring a national academic requirement for licensure, and reassessing the purpose of accreditation. Key steps have included hiring external experts, forming advisory groups, and engaging interest holders from across the engineering ecosystem through a multi-year process. Indicators of success for this priority include 1) a clear understanding of accreditation's purpose, 2) a unified academic standard for licensure, and 3) aligned systems for Engineers Canada and regulators. To date, task forces have reported on accreditation and licensure requirements, and multiple national and jurisdiction-level consultations have been held. Several next steps are underway:

- A series of Share Back sessions are scheduled with the regulators in the Fall to share the Path Forward Report's recommendations.
- A workshop will be held with the Engineers Canada Board, CEO Group, and the Presidents Group at the October Board meeting. The session will focus on the project journey, the key findings, and the Path Forward Report's recommendations.
- The Path Forward Report will be submitted to the Engineers Canada Board for decision at their December 2024 meeting.

A CEQB Member wanted to ensure the FEA project continued to account for mobility of students both domestically and internationally throughout their studies and pointed out an outcomes-based system could provide additional mobility. Mya assured the group this would not present a barrier, and they were correct in their assessment that it would provide additional mobility.

10 Feedback on Board Policy 9.2

Frank Collins, CEQB Chair, presented:

- The Governance Committee of the Board of Engineers Canada is required to review Board policies on a cyclical basis.
- Board Policy 9.2, Qualifications Board Products (Policy 9.2) is slated for review by the Governance Committee at its November 18, 2024, meeting.
- Following its review, the Governance Committee will recommend policy changes, as needed, to the Engineers Canada Board for its approval in February 2025.
- Policy 9.2 lays out the process that all CEQB products are required to follow in their development.
- As interest holders to this policy, CEQB is being asked by the Governance Committee for input that will feed into the review process.

11. 2025 Vice-Chair elections

Tim Kirkby, CEQB Senior Board representative, presented:

In April 2018, the Engineers Canada Board adopted the <u>6.10 Canadian Engineering Qualifications Board (CEQB) Policy</u>, which establishes terms of reference for the CEQB, the nominations process for the CEQB Executive Committee, and roles and responsibilities for the CEQB Chair.

Two candidates have put their names forward for the 2025 Vice-Chair position:

- Amy Hsiao: nomination was confirmed by Engineers PEI.
- Kamran Behdinan: nomination was confirmed by PEO.

Elections to the position of Vice-Chair were determined by secret ballot voting by the members of the CEQB. Voting took place using in-person or electronic ballots.



Amy Hsiao was the successful candidate as the next Vice Chair of the CEQB and will be put forward to the Engineers Canada Board for approval. **Action item 128.5**
