 - Establish Engineers Canada as a key partner and advisor on the infrastructure, climate change and diversity and inclusion files



Background and situational analysis

Engineers Canada:

- Is coming off 10 months of extensive, diverse engagement in Ottawa
 - Had 10 meetings with Ministers' Offices and federal departments
 - Engaged in 5 federal consultations in 2017 and 2 verbal testimonies to the House of Commons
- Had 42 MP meetings on Contact Day
- Is well-positioned to capitalize on Budget 2018
- Leveraging new opportunities in the Senate



Public policy objectives

- Invest in infrastructure climate vulnerability assessments
- Diversity and Inclusion
 - Improving current maternity and parental leave system
- Supporting the inclusion of professional engineers across federal departments




